a. Panel composition

a. Journal of open source software

The journal was discussed in the previous panel term. It has been suggested to level 1 but the view of the panel was that the journal does not meet the definition for scientific publication channel in level 1 criteria. The panel asked the JUFO steering group to discuss the classification of software journals.

The steering group decided to update the level 1 criteria so that also this type of journals could be considered to level 1. After the update, the definition for scientific publication channel is as follows: "The publication channel is specialised in the publication of scientific or scholarly research outcomes and it publishes peer-reviewed scientific publications on a regular basis. Channels that publish scientific data, software and methods that support the production of research outcomes are equated with channels that publish scientific or scholarly research outcomes."

The panel discussed if there is a need to re-evaluate the classification of this journal.

Decision:

The panel decided that the journal will be re-evaluated in May.

6. Conflicts of interest

The panel members were asked to disclose their engagements with publication channels in which they have been an editor or a member of the editorial board in the past five years.
